

Registration Terms and Conditions

Terms and conditions for participants attending the International Safety and Education Seminar 2019 in Antwerp.

Definition

These terms & conditions apply to all individually registered participants attending the International Safety and Education Seminar 2019, to be held in Antwerp from 19th – 20th November 2019.

Registration

Only fully completed registrations will be accepted. Each participant will receive electronic confirmation of their registration.

Price

Attending the seminar November 19th and 20th - 200 EURO (595 EURO for industry)

Attending social programme & dinner in Horta - 85 EURO

(only possible when attending the seminar)

If the maximum attendee capacity is reached, the organizers reserve the right to refuse any registration.

Cancellation

Participants can cancel their registration to the seminar, the following cancellation terms will be applicable:

- Cancellations made 2 months prior the seminar: no cancellation fee will be charged. The registration fee paid will be fully refunded
- Between 2 months and 1 month prior the seminar: a cancellation fee of 50% of the total registration fee will be charged
- Less than 1 month prior the seminar: a cancellation fee of 100% of the total registration fee will be charged.
- Replacement (change of a participant) of a confirmed registration is allowed, subject to a 25 EUR administration fee per participant.

Cancellation of the Seminar

In the event that the Seminar is postponed or cancelled due to events beyond the control of the Seminar organizers (force majeure) or due to events which are not attributable to wrongful intent or gross negligence of the Seminar organizers, the Seminar organizers cannot be held liable by participants for any damages, costs, or losses incurred, such as transportation and accommodation costs, financial losses, and any other miscellaneous expenses.

Modification of the programme

The Seminar organizers reserve the right to modify the programme at any time. All mention of the Seminar programme is only an indication and are subject to change.

Liability and Damage

The organizers cannot be held responsible for any personal injury, loss, damage or accident to private property, or for additional expenses incurred as a result of delays or changes in air, rail, road or other services, strikes, illness, weather and other causes.

The Participant shall be responsible for any damage or loss caused by the act, default or negligence of the Participant or his/her guest and shall pay on demand the amount required to remedy any such damage.

The Participant must ensure that he/she or members of his/her party and anyone visiting them at the Seminar behave in such a way that they do not cause a nuisance or unreasonable disruption to the Seminar, other participants, the Seminar Organizer or any other visitor of the Seminar venue.

The Seminar Organizer does not accept liability for the below and the participant is to indemnify the Seminar organizer against any claims arising from:

- failure to provide any of the services contracted and reserve the right to alter or cancel any booking due to circumstances beyond its control, including but not limited to industrial action, postal communications, flooding, storm supply of gas electricity and water, fire alarm evacuation, or any act of God. If this happens, the Seminar Organizer will use all commercially reasonable efforts to offer you alternative services.
